SECTION 4 – FIRST AID MEASURES

In case of eye contact : Flush eyes under eyelids with plenty of cool water for at least 15 minutes. If irritation persists, seek medical/advice attention.

SECTION 5 – FIRE-FIGHTING MEASURES

Suitable extinguishing media : Use extinguishing measures that are appropriate to local circumstances and the surrounding environment. Water spray, dry chemical or carbon dioxide are suitable.

SECTION 6 – ACCIDENTAL RELEASE MEASURES

- Personal precautions : Remove all sources of ignition. Ensure clean-up is conducted by trained personnel only. Refer to protective measures listed in Section 7 and 8.
- Environmental precautions : Do not allow contact with soil, surface or ground water.
- Methods of cleaning up : Eliminate all ignition sources if safe to do so. Stop leak if safe to do so. Contain spillage, and then collect with non-combustible absorbent material (e.g., sand earth, diatomaceous earth, vermiculite) and place in container for disposal according to local, state, and federal regulations (See Section 13). Flush away traces with water. For large spills, dike spilled material or otherwise contain material to ensure runoff does not reach a waterway.

SECTION 7 – HANDLING AND STORAGE

- Handling : Avoid contact with eyes. Take necessary action to avoid static electricity discharge (which might cause ignition of organic vapors). Keep away from fire, sparks and heated surfaces. Wash hands thoroughly after handling. Use only with adequate ventilation.
- Storage : Keep away from heat and sources of ignition. Keep in a cool, well-ventilated place. Keep away from oxidizing agents. Keep out of reach of children. Keep the container tightly closed. Store in suitable labeled containers.
- Storage temperature : 0 degree C to 45 degree C
